Henderson Songfest, Inc. Grant Project—2017

After a review of applications, Henderson Songfest, Inc. will award a grant from the proceeds of the 2017 Sandy Lee Watkins Songfest. The grant will be awarded for a program that impacts the residents of Henderson County, Kentucky. The amount of the grant will not be determined until after the 2017 Songfest. Grants pertaining to the arts and arts education, education, and veterans will be given preference. However, other non-profits will be considered according to funds available. **Incomplete grant applications will not be considered.**

The applicant(s) will submit the grant application by March 1, 2017 and agree to an interview, if requested. The grantee will be notified by April 15, 2017. If your organization is selected to receive funds from SLW Songfest, members of your organization will be expected to help with aspects of the Songfest to be determined. For example, your organization may be expected to promote ticket sales or provide volunteers to staff venues or related events.

The grantee should:

- Be a non-profit organization primarily serving residents of Henderson County, Kentucky
- Have a commitment to long-range planning and financial accountability
- Have a sound plan for your project or program
- Benefit residents of Henderson County

Projects not eligible:

- A proposal to reduce or retire debt
- Political campaigns
- Travel expenses for groups such as bands or sports teams
- Event sponsorships, annual appeals and membership contributions
- Organizations outside Henderson
